RESOLUTION AUTHORIZING TWO (2) VEHICLE SUB-LEASE AGREEMENTS BETWEEN THE COUNTY OF SALEM AND BR WILLIAMS EFFECTIVE SEPTEMBER 1, 2021

WHEREAS, the Salem County Board of County Commissioners wishes to enter into two (2) sublease agreements with BR Williams for the following programs:

1. Medical Transportation, designed to provide transportation to Delaware, Dialysis, Camden and Philadelphia appointments; and
2. Specialized Transportation Services, also known as Curb to Curb Transportation; and

WHEREAS, pursuant to an emergency contract entered into between the County of Salem and BR Williams authorized by Resolution #2021-~~268~~, BR Williams will provide Medical Transportation to Delaware, Dialysis, Camden and Philadelphia appointments with the following vehicles:

WHEREAS, the lease agreement with BR Williams for Medical Transportation shall coincide with the emergency contract for transportation services awarded to BR Williams on August 18, 2021 pursuant to Resolution #2021-~~268~~ ; and

WHEREAS, pursuant to a contract entered into between the County of Salem and BR Williams authorized by Resolution #2021-~~269~~ on August 18, 2021, BR Williams will provide Curb to Curb Transportation with the following vehicles:

2. The Salem County of Board of County Commissioners authorizes the lease agreement with BR Williams for Curb to Curb Transportation Services effective September 1, 2021 through December 31, 2022.
