RESOLUTION AUTHORIZING THE PROPOSED ACQUISITION OF A DEVELOPMENT EASEMENT ON CRISANTI FARM PITTSGROVE TOWNSHIP

WHEREAS, the Township of Pittsgrove submitted a Planning Incentive Grant (PIG) application to the State Agriculture Development Committee (SADC), pursuant to the State Agriculture Retention and Development Act, N.J.S.A. 4:1C-11 et. Seq., the Planning Incentive Grant Program, N.J.S.A. 4:1C-43.1, and the regulations thereunder. The County’s application includes a proposed funding plan which provides for the purchase of the development easements included in the application based upon the SADC using the sliding scale formula; and

WHEREAS, the application provided for the proposed acquisition of a Development Easement on the property owned by Dennis Crisanti and designated on the municipal tax map as Block 802, Lot 36 in the Township of Pittsgrove, County of Salem, State of New Jersey; and

WHEREAS, the State Agriculture Development Committee certified the fair market value of the development easement pursuant to N.J.A.C. 2:76-7.14 at \$5,100 per acre on November 19, 2020. The estimated cost sharing breakdown for the acquisition of the development easement is as follows (based on an estimated 21.2 net acres), subject to (a) the actual acreage to be covered by the development easement per the final survey which conforms to the farmland preservation program requirements, and (b) any additional adjustments pursuant to the State statute rule, regulation or policy:

WHEREAS, the Salem County Agriculture Development Board gave final approval to the proposed acquisition of a development easement on the Crisanti Farm, Block 802, Lot 36 in the township of Pittsgrove, on approximately 21.2 net acres at its July 28, 2021 meeting and is subject to the following:

- (a) The conveyance of a development easement which shall provide for the following:
 1. Exception: None
 2. Non-Agricultural use(s): None
 3. Dwellings: One (1)
 4. Residual Dwelling Site Opportunities: None

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners authorizes the proposed acquisition of a development easement on the Crisanti Farm in an amount of approximately \$21,624.00.


