RESOLUTION AMENDING 2021 CONTRACTS FOR PROVIDING DRUG AND ALCOHOL TREATMENT SERVICES FOR THE SALEM COUNTY ALCOHOL AND DRUG ABUSE SERVICES OFFICE


WHEREAS, the Board of Chosen Commissioners of the County of Salem through the Office of Alcohol and Drug Abuse Services has awarded contracts for Drug and Alcohol Treatment Services commencing on January 1, 2021 and terminating on December 31, 2021 by Resolution #2021-063; and

WHEREAS, there was a decrease in Maryville, Inc. need for funding for 2021 and Salem County Alcohol and Drug Abuse Services wishes to amend the Sub-Acute Detoxification Services contract by decreasing the originally allocated amount of \$15,000.00 (Fifteen Thousand Dollars and Zero Cents) by \$11,000.00 (Eleven Thousand Dollars and Zero Cents) as well as amend the Short-Term Residential Services contract by decreasing the originally allocated amount of \$8,000.00 (Eight Thousand Dollars and Zero Cents) to \$2,000.00 (Two Thousand Dollars and Zero Cents). The total reduction will be \$13,000.00 (Thirteen Thousand Dollars and Zero Cents); and

WHEREAS, there was an increase in need for recovery transportation services for 2021 and the Office of Alcohol and Drug Abuse Services wishes to amend the agreement with the contracted provider, B.R. Williams, by increasing the funding amount by \$13,000.00 (Thirteen Thousand Dollars and Zero Cents) for a total amount of \$28,000.00 (Twenty Eight Thousand Dollars and Zero Cents); and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2021 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the county's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Commissioners of the County of Salem approves the contract amendment authorizing Maryville, Inc. to decrease funds allocated by the County of Salem in the total amount of \$13,000.00 (Thirteen Thousand Dollars and Zero Cents) and approves the agreement amendment authorizing B.R. Williams to increase funds allocated by the County of Salem in the amount of \$13,000.00 (Thirteen Thousand Dollars and Zero Cents) for a total encumbered amount of \$28,000.00 (Twenty Eight Thousand Dollars and Zero Cents).
