**RESOLUTION TO AMEND RESOLUTION NO. 2021-107 ACCEPTING GRANT FUNDING FROM THE NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY FOR OPERATION HELPING HAND REIMBURSEMENT GRANT FUNDING FOR THE PROSECUTOR'S OFFICE [Subaward No. OHH-17-2019]**

**WHEREAS**, the Board of County Commissioners ("Board") recognizes a continuing need to assist the Prosecutor's Office, the New Jersey Department of Law and Public Safety ("Department") and law enforcement in endeavors to effectively address the Opioid Crisis in Salem County; and


**WHEREAS**, the Board accepted grant funding for the Salem County Prosecutor's Office from the Operation Helping Hand Reimbursement Grant Program by the execution of Resolution No. 2021-107 on March 3, 2021, in accordance with the grant acceptance letter on file with the Clerk of the Board; and

**WHEREAS**, Resolution No. 2021-107 contained an error indicating the amount of funding as \$46,619.00 with the actual amount of funding per the grant acceptance letter being \$47,619.00; and


**WHEREAS**, the purpose of this resolution is to correct the amount of the grant and to insert the additional funds of \$1,000.00 into the budget [actual funding 47,619.00 - \$46,619.00 = \$1,000.00].

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Salem that:

- 1) The Project Grant on file with the Clerk of the Board is approved and accepted.
- 2) The County Prosecutor, the Chief Finance Officer, the Project Contact person from the Prosecutor's Office, as well as any other necessary parties, are hereby authorized and directed to execute all project grant documents provided by the Division.
- 3) Five fully executed copies of this resolution shall be provided to the County Prosecutor forthwith.
