RESOLUTION APPROVING THE EXECUTION OF CHANGE ORDER #2-FINAL (YEAR THREE) REMOVAL OF BEAM GUIDE RAIL AND INSTALLATION OF BEAM GUIDE RAIL AT VARIOUS LOCATIONS THROUGHOUT THE COUNTY OF SALEM

WHEREAS, the County of Salem issued a Contract in the amount of \$130,000.00 to "Road Safety Systems, LLC" of Shamong, New Jersey RENEWING A CONTRACT FOR THE REMOVAL OF BEAM GUIDE RAIL AND INSTALLATION OF BEAM GUIDE RAIL AT VARIOUS LOCATIONS THROUGHOUT THE COUNTY OF SALEM, Resolution #2020-319, dated October 7, 2020; and

WHEREAS, N.J.A.C. 5:34-4.4(A) 3 requires that all change orders for capital projects be approved by the Salem County Board of County Commissioners; and

WHEREAS, the County Administrator and the County Engineer recommend approval of CHANGE ORDER #2-FINAL (YEAR THREE), as specifically described on the attached County of Salem Change Order Form, for a project decrease of FIFTEEN THOUSAND, EIGHT HUNDRED, FIFTY DOLLARS AND SIXTY-FIVE CENTS (\$15,850.65) which in addition to Change Order #1, represents a 12% DECREASE in the Total Contract Cost; and

WHEREAS, no additional funds are required through the execution of this Change Order.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that CHANGE ORDER #2-FINAL (YEAR THREE) be and is hereby approved for execution for the REMOVAL OF BEAM GUIDE RAIL AND INSTALLATION OF BEAM GUIDE RAIL AT VARIOUS LOCATIONS THROUGHOUT THE COUNTY OF SALEM; and

BE IT FURTHER RESOLVED, that the Director and Clerk of this Board of Salem County Commissioners be authorized to execute said CHANGE ORDER #2-FINAL (YEAR THREE).
