**RESOLUTION AMENDING THE FY18 AND FY20 SENIOR CITIZEN AND DISABLED RESIDENT TRANSPORTATION ASSISTANCE ACT (SCDRTAP) GRANT**

**WHEREAS**, the County of Salem adopted Resolution 2017-347 on December 6, 2017, authorizing the Office on Aging and Disabilities to receive funding from New Jersey Transit Corporation for FY18 Senior Citizen and Disabled Resident Transportation Assistance Act (SCDRTAP) Grant for period from January 1, 2018, through December 31, 2018, with no required match; and

**WHEREAS**, the County of Salem would like to amend and extend Resolution 2017-347 to use the remaining funds in account G-02-41-731-18A in the amount of \$2.26 during the period from January 1, 2022 through December 31, 2022 with no required match; and

**WHEREAS**, the County of Salem adopted Resolution 2019-428 on November 20, 2019, authorizing for the Office on Aging and Disabilities to receive funding from New Jersey Transit Corporation for FY20 Senior Citizen and Disabled Resident Transportation Assistance Act (SCDRTAP) Grant for period from January 1, 2020, through December 31, 2020, with no required match; and


**WHEREAS**, the County of Salem would like to amend and extend Resolution 2019-428 to use the remaining funds in account G-02-41-731-20A in the amount of \$120,822.01 during the period from January 1, 2022 through December 31, 2022 with no required match.

**NOW THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that:

1. The Salem County Board of County Commissioners would like to amend and extend Resolution 2017-347 to use the remaining funds of \$2.26 in account G-02-41-731-18A for the funding period January 1, 2022, through December 31, 2022, with no match required.
2. The Salem County Board of County Commissioners would like to amend and extend Resolution 2019-428 to use the remaining funds of \$120,822.01 in account G-02-41-731-20A for the funding period January 1, 2022, through December 31, 2022, with no match required.
