RESOLUTION ACCEPTING THE BUILDING RESILIENT INFRASTRUCTURE AND COMMUNITIES (BRIC) GRANT PROGRAM (CFDA#97.047) (BRIC) FROM THE STATE OF NEW JERSEY OFFICE OF EMERGENCY MANAGEMENT (CFDA#97.047) FY2020 PROJECT #EMN-2020-BR-056-0032

WHEREAS, the Salem County Sheriff's Office of Emergency Management made application to the State of New Jersey, Office of Emergency Management for FY20 Building Resilient Infrastructure and Communities (BRIC) funding; and

WHEREAS, the Salem County Sheriff's Office of Emergency Management has received notice of award from the Federal Emergency Management Agency (FEMA) through the State of New Jersey Office of Emergency Management is offering the BRIC Grant for the updating of Salem County Local Multi-Jurisdictional Hazardous Mitigation Plan which will include Salem County and all 15 municipalities within the county. The period of performance for the grant is December 24, 2021, to December 23, 2024, consisting of \$125,000.00 federal award amount and a non-federal in-kind match of \$41,686.79, totaling \$166,685.79; and

WHEREAS, the approved scope of work (SOW) includes the Salem County Local Multi-Jurisdictional Hazardous Mitigation Plan update which includes hazard mitigation identifications, risk/vulnerability assessment, mitigation strategy, plan adoption and plan maintenance.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

1. The project funding application as outlined and on file with the Department of Emergency Services is supported and approved.
2. The Salem County Sheriff's Office of Emergency Services, the Chief Finance Officer, the project contact person from the Department of Emergency Services, as well as any other necessary parties, are hereby authorized and directed to execute all grant requirements and documentation filings as directed by the New Jersey Office of Homeland Security and Preparedness.
3. Two fully executed copies of this resolution shall be provided to the Department of Emergency Services forthwith.
