**RESOLUTION AMENDING RESOLUTION 2022-23 AWARDING
A CONTRACT FOR MEDICAL DIRECTOR
FOR THE SALEM COUNTY CORRECTIONAL FACILITY**

WHEREAS, on January 5 , 2022, the Salem County Board of County Commissioners passed Resolution 2022-23 awarding a contract for professional services for Medical Director at the Salem County Correctional Facility via a "fair and open process"; and

WHEREAS, said Resolution authorized a contract in the amount of \$137,000.00; and

WHEREAS, after further review and in consideration of additional duties undertaken by the medical director pertaining to the Medication Assisted Treatment (MAT) program as more fully outlined in the Request for Proposals dated December 23, 2021, the County has determined that a need exists to increase the salary of the Medical Director for the Salem County Correctional Facility to the sum of \$155,000.00 per year; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Board of County Commissioners of the County of Salem hereby amends Resolution 2022-23 to award a contract for the **Medical Director Salem County Correctional Facility**, in the amount not to exceed \$155,000.00 (One Hundred Fifty Five Thousand Dollars and Zero Cents.)
2. The contract commencing, retroactively, January 1, 2022 and terminating December 31, 2022, or until a successor is appointed, whichever is later, shall be completed in full accordance with the terms and conditions of the contract.
3. The County Commissioners Director and the Clerk of the Board shall be authorized to execute said contracts.


