**RESOLUTION TO AMEND RESOLUTION #2021-404 TO ACCEPT AND EXECUTE  
CY 2022 JDAI GRANT FUNDING FOR THE SALEM COUNTY YOUTH SERVICES  
COMMISSION FROM THE NEW JERSEY JUVENILE JUSTICE COMMISSION  
AWARD #JDAI-22-IF-17**

**WHEREAS**, the Board of Chosen Freeholders ("Board") recognizes a continuing need to assist the Salem County Youth Services Commission ("SCYSC") and County Council on Juvenile Systems Improvement ("CJJSI") in efforts to provide approved Juvenile Detention Alternatives Initiative ("JDAI") Innovations programming for youth adjudicated delinquents; and

**WHEREAS**, the SCYSC and CJJSI approved a grant application from the New Jersey Justice Commission for the JDAI Grant Program in accordance with the certified assurances, grant conditions, and award notice on file with the Clerk of the Board; and

**WHEREAS**, the Board recognizes the grant reimbursement is for a one year period from January 1, 2022 to December 31, 2022 with total funding of \$120,000.00.


**WHEREAS**, this resolution will amend the title of Resolution #2021-404 to reflect the correct New Jersey Justice Commission Award number as #JDAI-22-IF-17.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem that:

1. The project grant on file with the Clerk of the Board is approved and accepted.
2. The Deputy Director of Operations, the Chief Finance Officer, the Salem County Youth Services Administrator from the Salem Inter Agency Council of Human Services Inc., and any other necessary parties, are hereby authorized and directed to execute all project grant documents provided by the Juvenile Justice Commission.
3. Three fully executed copies of this resolution shall be provided to the Salem County Inter Agency Council of Human Services forthwith.
