RESOLUTION AWARDING A NON-FAIR AND OPEN CONTRACT FOR TRUCK REPAIRS FOR THE COUNTY OF SALEM ROAD DEPARTMENT

WHEREAS, the County of Salem has a need to acquire truck repairs for the County of Salem Road Department; pursuant to the provisions of N.J.S.A. 19:44A-20.4 and

WHEREAS, the value of said acquisition will exceed \$17,500.00 (Seventeen Thousand Five Hundred Dollars and Zero Cents); and

WHEREAS, Hunter Jersey Peterbilt has submitted a quotation indicating they will provide the truck repairs at a total cost of \$31,190.92 (Thirty-One Thousand One Hundred Ninety Dollars and Ninety-Two Cents.)

WHEREAS, Hunter Jersey Peterbilt has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the County of Salem in the previous year, and will prohibit **Hunter Jersey Peterbilt** from making any reportable contributions through the term of the contract, and

WHEREAS, The Salem County CFO has certified that funding for this contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds contained in the temporary and final 2022 Budget of the County of Salem.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Board of County Commissioners of the County of Salem authorizes a contract with ~~Hunter Jersey Peterbilt as described herein.~~
2. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with the resolution.


