RESOLUTION AWARDING A NON-FAIR AND OPEN CONTRACT FOR THE LOCK RETROFIT PROJECT AT THE SALEM COUNTY CORRECTIONAL FACILITY

WHEREAS, the County of Salem has a need to acquire materials to complete a lock retrofit project for the Salem County Correctional Facility; pursuant to the provisions of N.J.S.A. 19:44A-20.4 and

WHEREAS, the value of said acquisition will exceed \$17,500.00 (Seventeen Thousand Five Hundred Dollars and Zero Cents); and

WHEREAS, Craftmaster Hardware has submitted a quotation indicating they will provide the materials necessary at a total cost of \$31,628.00 (Thirty-One Thousand Six Hundred Twenty-Eight Dollars.)

WHEREAS, Craftmaster Hardware has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the County of Salem in the previous year, and will prohibit **Craftmaster Master Hardware** from making any reportable contributions through the term of the contract, and


WHEREAS, The Salem County CFO has certified that funding for this contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds contained in the temporary and final 2022 Budget of the County of Salem.

1. The Board of County Commissioners of the County of Salem authorizes a contract with Craftmaster Hardware as described herein.
2. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with the resolution.


