RESOLUTION OF THE FIRST READING TO FIX THE ANNUAL SALARY OF THE SALEM COUNTY BOARD OF COUNTY COMMISSIONERS, THE SALEM COUNTY SHERIFF, THE SALEM COUNTY CLERK, THE SALEM COUNTY SURROGATE AND THE SALEM COUNTY PROSECUTOR

WHEREAS, N.J.S.A. 40:20-72, originally passed in 1944, requires that the Board of County Commissioners in each county, by resolution, fix the annual salary of Members of the Board; and

WHEREAS, N.J.S.A. 40A:9-104, originally passed in 1971, requires that the Board of County Commissioners in each county, by resolution, shall fix the annual salary of the Sheriff; and

WHEREAS, N.J.S.A. 40A:9-76, originally passed in 1971, requires that the Board of County Commissioners in each county, by resolution, shall fix the annual salary of the County Clerk; and

WHEREAS, N.J.S.A. 2B:14-3, originally passed in 1999, requires that the Board of County Commissioners in each county, by resolution, shall fix the annual salary of the Surrogate; and

WHEREAS, N.J.S.A. 2A:158-10, originally passed in 1952, requires that the Board of County Commissioners in each county, by resolution, shall fix the annual salary of the County Prosecutor;
and

WHEREAS, in accordance with N.J.S.A. 40:20-72 and N.J.S.A. 40A:4-6, the County is required to hold a Public Hearing.

NOW, THEREFORE, BE IT RESOLVED that in accordance with N.J.S.A. 40:20-72, the Board of County Commissioners of the County of Salem shall fix the 2022 annual salary of the Salem County Commissioner Board as follows:

Salem County Commissioner – Director	\$24,026.00
Salem County Commissioner – Member	\$23,117.00
