RESOLUTION AMENDING RESOLUTION 2022-067 AUTHORIZING THE EXECUTION OF THE STATE COMMUNITY PARTNERSHIP GRANT FOR THE SALEM INTER-AGENCY COUNCIL 2022 YOUTH SERVICES COMMISSION

WHEREAS, The County of Salem adopted Resolution 2022-067 which listed Family Court Service Funds as \$100,231.00 and the Comprehensive Funding Total as \$301,277.00.

WHEREAS, there was a typing error on Resolution 2022-067 which the Inter-Agency Council wishes to correct, making a corrective amount of Family Court Service Funds as \$100,261.00 and the corrective Comprehensive Funding Total as \$301,227.00; and

WHEREAS, the Juvenile Justice Commission (JJC) has allocated the following funding to the County of Salem Youth Services Commission:

WHEREAS, the Salem County Youth Services Commission has recommended allocation of these funds based on a renewal of the prior year’s plan and monitoring results; and

WHEREAS, the Salem County Board of Chosen Commissioners agrees with these recommendations and authorizes Salem County Inter-Agency Council to enter into agreements for the following services.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that the County of Salem acknowledge and accept these corrective figures and allocate the JJC Partnership and Family Court funding as follows:
