RESOLUTION AWARDING A NON-FAIR AND OPEN CONTRACT FOR MOWER EQUIPMENT PURCHASES FOR THE SALEM COUNTY CORRECTIONAL FACILITY

WHEREAS, the County of Salem has a need to acquire mower equipment for the Salem County Correctional Facility; pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the value of said acquisition will exceed \$17,500.00 (Seventeen Thousand Five Hundred Dollars and Zero Cents); and

WHEREAS, Weber's Power Equipment, Inc. has submitted a quotation indicating they will provide the equipment at a total cost of \$19,151.36 (Nineteen Thousand One Hundred Fifty One Dollars and Thirty Six Cents) net of trade in; and

WHEREAS, Weber's Power Equipment, Inc. has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the County of Salem in the previous year, and will prohibit Weber's Power Equipment, Inc. from making any reportable contributions through the term of the contract; and

WHEREAS, The Salem County CFO has certified that funding for this contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds contained in the temporary and final 2022 Budget of the County of Salem.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Board of County Commissioners of the County of Salem authorizes a contract with Weber's Power Equipment, Inc. as described herein.
2. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with the resolution.


