**RESOLUTION AWARDING A NON-FAIR AND OPEN CONTRACT FOR
INFOSHARE SOFTWARE MAINTENANCE FOR THE SALEM COUNTY
PROSECUTOR'S OFFICE**

WHEREAS, the County of Salem has a need for maintenance of Infoshare software modules for the Salem County Prosecutor's Office; pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the value of said contract will exceed \$17,500.00 (Seventeen Thousand Five Hundred Dollars and Zero Cents); and

WHEREAS, Computer Square, Inc. d/b/a CSI Technology Group has submitted a quotation indicating they will provide the maintenance necessary at a total cost of \$43,600.00 (Forty-Three Thousand Six Hundred Dollars); and

WHEREAS, Computer Square, Inc. d/b/a CSI Technology Group has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the County of Salem in the previous year, and will prohibit Computer Square, Inc. d/b/a CSI Technology Group from making any reportable contributions through the term of the contract; and

WHEREAS, The Salem County CFO has certified that funding for this contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds contained in the temporary and final 2022 Budget of the County of Salem.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Board of County Commissioners of the County of Salem authorizes a contract with Computer Square, Inc. d/b/a CSI Technology Group as described herein.
2. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with the resolution.
