RESOLUTION AMENDING RESOLUTION 2021-344 ENDORSING YOUTH SERVICES COMMISSION (YSC) 2022 STATE/COMMUNITY PARTNERSHIP AND FAMILY COURT SERVICES APPLICATION TO THE STATE OF NEW JERSEY JUVENILE JUSTICE COMMISSION FOR FUNDING FOR THE PERIOD JANUARY 1, 2022 TO DECEMBER 31,2022

WHEREAS, The County of Salem adopted Resolution 2021-344 which endorsed YSC 2022 State/Community Partnership and Family Court Services Application to the State of New Jersey Juvenile Justice Commission for funding for the period of January 1, 2022 to December 31, 2022; and

WHEREAS, there was a typing error on Resolution 2021-344 which the Salem County Inter Agency Council of Human Services wishes to correct, making a corrective statement that the application endorsed pertains to Federal Award numbers SCP-22-PS-17, SCP-22-PM-17, and FC-21-17; and

WHEREAS, it is desired for the Salem County Board of County Commissioners to endorse the YSC to participate in the State of New Jersey’s Juvenile Justice Commission’s State/Community Partnership and the Family Court Services funded programs beginning January 1, 2022 to December 31, 2022; and

WHEREAS, the funding will provide detention, diversion, prevention, and reentry services for family court-involved and other youth not court involved within the County of Salem as well as the administration of these programs; and

WHEREAS, the following is a breakdown of the State/Community Partnership and the Family Court Services Funding Application for Federal Award numbers SCP-22-PS-17, SCP 22-PM-17, and FC-21-17

Justice Commission with a total award amount of \$301,227.00 from January 1 to December 31, 2022; and

BE IT FURTHER RESOLVED that the County of Salem, Human Services Director is responsible for grant implementation of Federal Award numbers SCP-22-PS-17, SCP-22-PM-17, and FC-21-17; and

BE IT FURTHER RESOLVED that the YSC will submit to the State of New Jersey Juvenile Justice Commission an application and plan update for the CY 2022 State/Community Partnership and Family Court Services Grant Funding for Federal Award numbers SCP-22-PS-17, SCP-22-PM-17, and FC-21-17 including a spending plan and that the County model the programs to tis requirements is hereby adopted.
