**RESOLUTION PROHIBITING NORMAL TRAFFIC,
SOUTH RAILROAD AVENUE, COUNTY ROAD #602
IN OLDMANS TOWNSHIP, SALEM COUNTY
FOR THEIR ANNUAL PEDRICKTOWN DAY CELEBRATION**

WHEREAS, a request was received from "Oldmans Township" for their Annual PEDRICKTOWN DAY CELEBRATION for an assemblage along a portion of South Railroad Avenue, County Road #602 from the Intersection of Mill Street, County Road #642 to Freed Road, a local road, on Saturday, October 8, 2022 between the hours of 8:00 AM and 5:00 PM; and

WHEREAS, N.J.S.A. 39:4-197.1 requires a Municipality to receive consent from the County when normal traffic is prohibited by a parade, procession or assemblage; and

WHEREAS, South Railroad Avenue, County Road #602 is a road under the jurisdiction of the County of Salem.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that the request to prohibit through traffic for an ASSEMBLAGE along South Railroad Avenue, County Road #602 on Saturday, October 8, 2022 from 8:00 AM to 5:00 PM is approved subject to the following conditions:

1. In keeping with the Governor of the State of New Jersey's COVID 19 directive requiring social distancing and the use of proper PPE, if still in effect.
2. Installation of proper detour signs and notice to the Salem County 911 Central Dispatch of the road closure.
3. Flag personnel at both ends of the assemblage area, and all side streets and access areas, to direct traffic.
4. A copy of this Resolution shall be provided to the local governing body.
5. A copy of this Resolution shall be provided to the municipal Office of Emergency Management and Law enforcement with jurisdiction over the location for the preparation of an "Event Safety Analysis".
6. A copy of this Resolution shall be provided to the Salem County Public Works Department requesting the County Message Boards be made available at least 24 hours prior to the event if needed based on the "Event Safety Analysis".
7. Copies of this Resolution shall also be provided to the Salem County Engineer's Office, the Salem County Office of Emergency Management and the Salem County Sheriff's Department.
