RESOLUTION APPROVING CHANGE ORDER #1 FOR SOUTH JERSEY LEGAL SERVICES, INC.

WHEREAS, the Salem County Board of County Commissioners through the Office on Aging & Disabilities has an agreement with South Jersey Legal Services, Inc. to provide Legal Presentations to senior Salem County residents which was adopted by Resolution 2021-431 at the December 28, 2021 Commissioner meeting in amount of \$1,875.00; and

WHEREAS, the Office On Aging & Disabilities finds it necessary to increase the funding by the amount of \$330.00 (Three Hundred Thirty Dollars and Zero Cents); and

WHEREAS, all other terms of the original contract shall remain in force.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

- 1. The Salem County Board of County Commissioners approves the issue of Change Order #1 authorizing South Jersey Legal Services, Inc. to increase funds encumbered by the County of Salem in the amount of \$330.00 for a total contract amount of \$2,205.00; and
2. The Commissioner Director and the Clerk of the Board shall be authorized to sign Change Order #1.
