RESOLUTION AUTHORIZING A MEMORANDUM OF AGREEMENT WITH ANGELA PATTERSON D/B/A FAIRIES CLEANING CREW FOR HOUSEKEEPING SERVICES


WHEREAS, the Board of County Commissioners of the County of Salem wishes to enter into a memorandum of agreement with Angela Patterson d/b/a Fairies Cleaning Crew to provide housekeeping services to Salem County residents 60+ years of age for the Salem County Office on Aging & Disabilities; and

WHEREAS, the cost of this agreement is not to exceed \$15,000.00 (Fifteen Thousand Dollars and Zero cents); and

WHEREAS, this agreement shall be for services beginning September 22, 2022 through December 31, 2022, with an option for 2 (two) additional 1 (one) year renewals for 2023 and 2024.


NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

2. This agreement shall be for services beginning September 22, 2022 through December 31, 2022, with an option for 2 (two) additional 1 (one) year renewals for 2023 and 2024.


