RESOLUTION ENDORSING YOUTH SERVICES COMMISSION (YSC) 2023 STATE/COMMUNITY PARTNERSHIP SCP-23-PS-17, SCP-23-PM-17, AND FAMILY COURT SERVICES FC-23-17 APPLICATION TO THE STATE OF NEW JERSEY JUVENILE JUSTICE COMMISSION FOR FUNDING FOR THE PERIOD OF JANUARY 1, 2023 TO DECEMBER 31, 2023

WHEREAS, it is desired for the Salem County Board of County Commissioners to accept and endorse the State/Community Partnership and the Family Court Services Plan Update and Funding Application and authorize the Youth Services Commission to apply to the State of New Jersey Juvenile Justice Commission for SCP-23-PS-17, SCP-23-PM-17 State/Community Partnership and FC-23-17 Family Court Services funds for the period of January 1, 2023 to December 31, 2023; and

WHEREAS, the State/Community Partnership and the Family Court Services Grant Funds shall be for a total amount of \$320,401.00 for the period of January 1, 2023 to December 1, 2023 ; and

WHEREAS, it is desired for the Salem County Board of County Commissioners to endorse the Youth Services Commission to participate in the State of New Jersey Juvenile Justice Commission’s State/Community Partnership and the Family Court Services funded programs beginning January 1, 2023 to December 31, 2023; and

WHEREAS, the funding will provide detention, diversion, prevention, and reentry services for family court-involved and other youth not court involved with in the County of Salem as well as the administration of these programs; and

WHEREAS, the following is a breakdown of the State/Community Partnership and the Family Court Services Funding Application:

BE IT FURTHER RESOLVED that the County of Salem, Human Services Director is responsible for grant implementation; and

BE IT FURTHER RESOLVED that the Youth Services Commission will submit to the State of New Jersey Juvenile Justice Commission an application and plan update for CY 2023 State/Community Partnership and Family Court Services Grant Funding including a spending plan and that the County model the programs to its requirements is hereby adopted.
