**RESOLUTION AWARDING A RENEWAL CONTRACT FOR THE PROVISION OF ON-SITE FOOD SERVICES AND FOOD SERVICE MANAGEMENT FOR THE SALEM COUNTY CORRECTIONS FACILITY**

**WHEREAS**, the Salem County Purchasing Agent, as authorized contracting Agent for the Board of Chosen Freeholders of the County of Salem requested, received, and opened sealed proposals on September 13, 2019, at 2:00 PM prevailing time for Providing On-Site Food Services and Food Service Management for the Salem County Correctional Facility. The receipt of said bids was duly advertised in accordance with the law and in such case made and provided; and

**WHEREAS**, it was determined that the company of Summit Food Services, Inc., provided the lowest responsible and responsive bid and substantially met the necessary qualifications, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; said bid documents shall become a part of the contract; and

**WHEREAS**, the Board of Chosen Freeholders of the County of Salem adopted Resolution 2019-373 awarding a Contract to Summit Food Service, Inc; and

**WHEREAS**, the contract provided for two (2) additional one year renewal options; and

**WHEREAS**, Summit Food Services, Inc. and the Salem County Board of County Commissioners, along with the Salem County Corrections Facility are interested in exercising the first one (1) year renewal option of said contract with the same terms and conditions as outlined in the bid specifications and proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that:

1. The Salem County Board of County Commissioners hereby awards a renewal contract for the provision of Food Service and Food Service Management for the Salem County Correctional Facility, subject to the review of the County Solicitor, to Summit Food Services, Inc., 500 East 52nd Street North, Sioux Falls, South Dakota 57104, the cost of which shall not exceed \$961,753.00 for the first renewal period of the contract, with \$240,438.34 being allocated for the remainder of 2022; and
2. This competitive contract shall commence on October 5, 2022, and terminate on October 4, 2023, with the second one (1) year renewal option remaining. This shall be completed in full accordance with the terms and conditions of the contract; and

3. The County Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


