RESOLUTION RENEWING CONTRACT FOR FURNISHING AND DELIVERING ROCK SALT FOR THE COUNTY OF SALEM AND THE MEMBERS OF THE SALEM COUNTY COOPERATIVE PRICING SYSTEM IDENTIFIER NUMBER 75-SCCP

WHEREAS, The Salem County Purchasing Agent, as authorized contracting Agent for the Board of County Commissioners for the County of Salem, has received revised pricing for Furnishing and Delivering Rock Salt for the County of Salem and members of the Salem County Cooperative Pricing System (75-SCCP) and;

WHEREAS, the existing terms of the agreement from the sealed bid award opened on August 13, 2021 allow revised pricing for year two when made by the contractor in writing and accepted by the County and;

WHEREAS, the company of Riverside Construction Materials (Silvi Group Companies), who was awarded the 2021-2022 contract for delivering rock salt has submitted revised pricing for a 2022-2023 (year two) renewal agreement with pricing of \$77.50 per ton and;

WHEREAS, the period of this contract will commence October 19, 2022 and will terminate August 31, 2023, with one (1) additional one (1) year renewal option.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of the County of Salem hereby awards a renewal contract for Furnishing and Delivering Rock Salt for the County of Salem and members of the Salem County Cooperative Pricing System (75-SCCP), subject to the review of the County Solicitor, to **Riverside Construction Materials (Silvi Group Companies), 355 Newbold Road, Fairless Hills, PA 19030.**

1. For the purpose of Furnishing and Delivering Rock Salt for the County of Salem and the members of the Salem County Cooperative Pricing System Identifier Number 75-SCCP. Cost per ton shall not exceed \$77.50 (Seventy-Seven Dollars and Fifty Cents) per ton and total cost over the term of the contract shall not exceed \$500,000 (Five Hundred Thousand Dollars and Zero Cents) with the cost of CY 2022 not to exceed \$80,000 (Eighty Thousand Dollars and Zero Cents).
2. The contract commences October 19, 2022 and will terminate August 31, 2023, with one (1) additional one (1) year renewal option. This shall be completed in full accordance with the terms and conditions of the contract.
3. The Board of County Commissioners Deputy Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


