RESOLUTION REJECTING PROPOSALS SUBMITTED FOR PROVIDING TRANSPORTATION FOR SALEM COUNTY SENIOR RESIDENTS 60 YEARS OF AGE OR OLDER, PERSONS WITH DISABILITIES UNDER 60, AND GENERAL PUBLIC IN A DESIGNATED RURAL AREA PROVIDED BY THE SALEM COUNTY OFFICE ON AGING AND DISABILITIES

WHEREAS, The Salem County Purchasing Agent as authorized Contracting Agent for the Salem County Board of County Commissioners requested, received, and opened sealed proposals on October 25, 2022 @ 11:00 am prevailing time, for Providing Transportation for Salem County Senior Residents 60 Years of Age or Older, Persons with Disabilities under the age of 60, and General Population in a Designated Rural Area Provided by the Salem County Office on Aging and Disabilities; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all proposal results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 Fifth Street, Salem, New Jersey, as required by law; and

WHEREAS, the Governing Body of the contracting unit, upon recommendation of the Salem County Department of Health and Office on Aging and Disabilities Services and the Proposal Review Panel, has decided that the lowest cost proposal exceeds the contracting units appropriations for the goods and services pursuant to N.J.S.A. 40A:11-13.2 (b), the Purchasing Agent recommends that the Board of Commissioners of the County of Salem reject all bids at this time.


NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that

1. The Board of County Commissioners hereby rejects the proposals submitted for Providing Transportation for Salem County Senior Residents 60 Years of Age or Older, Persons with a Disability under the age of 60, and General Population in a Designated Rural Area Provided by the Salem County Office on Aging and Disabilities, subject to review of the County Solicitor; and
2. Be it further resolved that the Board of County Commissioners further stipulates that all bidders be so informed. This shall be completed in full accordance with the provisions and conditions of N.J.S.A. 40A:11-13.2; and

3. Be it further resolved that the Board of County Commissioners authorizes the Salem County Purchasing Agent to re-issue a revised Request for Proposal in order to solicit responses for these services that are within the budgetary estimate for the program.
