**RESOLUTION APPROVING THE EXECUTION OF CHANGE ORDER #2 TO A CONTRACT WITH BAYADA NURSES FOR PROVIDING CERTIFIED HOME HEALTH AIDE – TITLE III B TO THE DISABLED AND/OR ELDERLY RESIDENTS OF SALEM COUNTY UNDER THE OLDER AMERICANS ACT**

**WHEREAS**, the Salem County Board of County Commissioners through the Office on Aging & Disabilities has an agreement with Bayada Nurses to provide Certified Home Health Aide – Title III B services for the Salem County Senior Residents 60 years of Age or Older and Limited Disabled Residents which was adopted at the December 28, 2021, Commissioner meeting on Resolution 2021-435 in amount of \$10,500; and

**WHEREAS**, N.J.A.C. 5:34-4.49a03 requires that all change orders for services be approved by the Salem County Board of County Commissioners; and

**WHEREAS**, N.J.A.C. 5:34-4.49a03 requires that all change orders which exceed 20% of the original contract amount for services be approved by the Salem County Board of County Commissioners; and

**WHEREAS**, the Office On Aging & Disabilities wishes to increase their funding by the amount of \$5,534.90 (Five Thousand Five Hundred Thirty Four Dollars and Ninety Cents); and

**WHEREAS**, the Salem County Purchasing Agent recommends the approval of Change Order #2 in the amount of \$5,534.90 (Five Thousand Five Hundred Thirty Four Dollars and Ninety Cents) increasing the contract to a total amount of \$16,034.90 (Sixteen Thousand Thirty Four Dollars and Ninety Cents). This increase exceeds the 20% regulation; and


**WHEREAS**, all other terms of the original contract shall remain in force; and

**WHEREAS**, the Salem County Treasurer has certified that the funding for this contract in 2022 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners approves the issue of Change Order #2 authorizing Bayada Nurses to increase funds encumbered by the County of Salem in the amount of \$5,534.90 for a total contract amount of \$16,034.90.
2. The Salem County Treasurer shall certify to the Salem County Board of County Commissioners that the funds are available for payment of the increased amount as necessitated by the issuance of Change Order #2.

3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said Change Order #2.
