**RESOLUTION APPROVING AGREEMENT BETWEEN CUMBERLAND COUNTY
PROSECUTOR AND SALEM COUNTY PROSECUTOR DATED
SEPTEMBER 7, 2022**

WHEREAS, the Salem County Prosecutor's Office has established a Forensic Nurse Examiner (FNE) Program to be staffed by duly trained, on-call Forensic Nurse Examiners, and

WHEREAS, the Cumberland County Prosecutor's Office and the Salem County Prosecutor's Office (hereinafter referred to as "the parties") entered into a shared services agreement to develop a joint Sexual Assault Response TEAM (SART) and to share a Sexual Assault Nurse Examiner (SANE)/SART Team Coordinator.

WHEREAS, the Cumberland County and Salem County Board of Commissioners approved a shared services agreement memorializing same on September 7, 2022.

WHEREAS, the parties agreed to compensation for the SANE/SART Coordinator as outlined in paragraph 3(vii) of the Shared Services Agreement.

WHEREAS, the SANE/SART Coordinator is required to travel to and from both offices and to other facilities to complete the necessary duties of the position;

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Commissioners of the County of Salem as follows:

1. The Board of Chosen Commissioners of the County of Salem approves the Agreement Between the Cumberland County Prosecutor and the Salem County Prosecutor Dated September 7, 2022 whereby the Cumberland County Prosecutor's Office shall purchase, maintain and insure a 2023 Ford Escape (AWD) Base Model vehicle, which shall remain the property of the Cumberland County Prosecutor's Office, for use by the SANE/SART Coordinator in the performance of her duties. The Salem County Prosecutor's Office shall provide fuel for the SANE/SART Coordinator's travel to and from both counties. Such fuel expenses shall be charged against the Salem County Prosecutor's Office budget or appropriate Salem County Prosecutor's Office grant funding as in the normal course of other vehicles operated by the Salem County Prosecutor's Office.

2. The Commissioner Director and the Clerk of the Board shall be authorized to execute said agreement upon compliance by the firm with all requirements and specifications.
