RESOLUTION REQUESTING AN AGREEMENT DATE EXTENSION NEW JERSEY DEPARTMENT OF TRANSPORTATION FISCAL YEAR 2017 MILL AND OVERLAY PROGRAM FEDERAL AID AGREEMENT NO. 18-DT-BLA-784 NJDOT JOB #7105306

WHEREAS, the Salem County Board of Chosen Freeholders adopted Resolution #2018-346 on October 17, 2018 approving funding for a reimbursement Grant for the "FISCAL YEAR 2017 MILL AND OVERLAY PROGRAM", FEDERAL AID PROJECT NO. STP-SJ-0551(300), NJDOT JOB #7105306" for the "Resurfacing and Safety Improvements of Hook Road, County Road #551, Phase 1", and

WHEREAS, the original Grant period commenced on JANUARY 25, 2019 and terminates on DECEMBER 31, 2022; and

WHEREAS, the declaration of a "State of Emergency" by the Governor of New Jersey due to Covid-19 impacted staffing and work production from the very beginning of this project through and including the Covid-19 Omicron variant; and


WHEREAS, delays occurred throughout this Project that were out of the control of Salem County; and
WHEREAS, the Salem County Board of County Commissioners adopted Resolution #2022-433 on November 16, 2022 to amend the aforementioned Grant period; and

WHEREAS, additional information received from the New Jersey Department of Transportation required that the terms of the request included in Resolution #2022-433 be modified; and

WHEREAS, due to the foregoing circumstances, the County Engineer and Administrator would like to request the Agreement and Date extension be modified to December 31, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that a formal request be made to the New Jersey Department of Transportation to approve an extension to the FISCAL YEAR 2017 MILL AND OVERLAY PROGRAM, FEDERAL AID AGREEMENT NO. 18-DT-BLA-784, NJDOT JOB #7105306 until December 31, 2023.
