**RESOLUTION AUTHORIZING AN APPLICATION TO THE NEW JERSEY OFFICE OF INFORMATION TECHNOLOGY FOR FUNDING THE SALEM COUNTY 911 PUBLIC SAFETY ANSWERING POINT (PASP) CYBER SECURITY UPGRADES.**

**WHEREAS**, the Salem County Board of County Commissioners recognize the need to work with the County 911 Center and with the County Information Technology Department and attempt to obtain funding that will allow the County to improve cybersecurity on the PSAP network; and

**WHEREAS**, the New Jersey Office of Information Technology has offered funding to Salem County 911 Public Safety Answering Point (PSAP), to enhance cyber security or PSAP regionalization and that the County has proactively created a fully regional PSAP, maintaining six answering positions twenty-four hours per day and the grant guidance also allows for improvement of cyber security within PSAP networks; and

**WHEREAS**, the grant application seeks funds appropriated under the FY-2023 Next Generation 9-1-1 Grants for the period of July 1, 2022, through June 30, 2023, in the awarded amount of \$27,300.00 to purchase cyber security upgrades.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that:

1. The project funding application as outlined and on file on the NJ.gov webpage.
2. The Salem County Sheriff's Office Department of Emergency Services, the Chief Finance Officer, the project contact person from the Salem County Sheriff's Office Department of Emergency Services, as well as any other necessary parties, are hereby authorized and directed to execute all grant requirements and documentation filings as directed by the New Jersey Office of Information Technology.
3. Two fully executed copies of this resolution shall be provided to the Salem County Sheriff's Office Department of Emergency Services forthwith.
