RESOLUTION AWARDING A RENEWAL CONTRACT FOR BAYADA HOME HEALTH CARE TO PROVIDE CERTIFIED HOME HEALTH AIDE-TITLE IIIB SERVICES TO SALEM COUNTY SENIOR RESIDENTS 60 YEARS OF AGE OR OLDER AND LIMITED DISABLED RESIDENTS UNDER THE OLDER AMERICANS ACT-AREA PLAN GRANT

WHEREAS, the Salem County Purchasing Agent as authorized contracting agent for the Salem County Board of County Commissioners requested, received, and opened sealed proposals on November 30, 2021, at 11:00 AM prevailing time for Providing Services and Programs for the Salem County Senior Residents 60 Years of Age or Older and Limited Disabled Residents; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all bid results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 Fifth Street, in the County of Salem, New Jersey, as required by law; and

WHEREAS, the Salem County Board of County Commissioners awarded a contract on November 30, 2021, by Resolution 2021-435 to Bayada Home Health Care in the amount of \$10,500.00 (Ten Thousand Five Hundred Dollars and Zero Cents) in IIIB Funds; and a required Provider Match of \$2,625.00 (Two Thousand Six Hundred Twenty-Five Dollars and Zero Cents); and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract shall be encumbered in account G-02-41-700-23B-303 Area Plan Grant in accordance with NJ.A.C. 50:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget.


NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

1. The Board of County Commissioners of the County of Salem hereby awards a renewal contract for **Certified Home Health Aide Services -Title IIIB** for the Salem County Office on Aging, subject to the approval of the County Solicitor, to Bayada Home Health Care, located at 3071 E Chestnut Ave Suite F18 Vineland, NJ 08361 in the amount of \$10,500.00 (Ten Thousand Five Hundred Dollars and Zero Cents) in IIIB Funds; and a required Provider Match of \$2,625.00 (Two Thousand Six Hundred Twenty-Five Dollars); and at a Cost Per Unit of 33.00 during 2023 not to exceed \$13,125.00 (Thirteen Thousand One Hundred Twenty-Five Dollars).
2. The contract period is January 1, 2023, through December 31, 2023. The contract shall be completed in full accordance with the terms and conditions of the contract with a remaining one (1) year renewal option available (January 1, 2024, through December 31, 2024).

3. The County Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


