RESOLUTION AWARDING A RENEWAL CONTRACT TO PUERTO RICAN ACTION COMMITTEE OF SOUTHERN NJ TO PROVIDE ASSISTED TRANSPORTATION TO THE DISABLED AND/OR ELDERLY RESIDENTS OF SALEM COUNTY UNDER THE OLDER AMERICANS ACT-AREA PLAN GRANT

WHEREAS, Salem County Purchasing Agent as authorized contracting agent for the Board of County Commissioners, requested, received, and opened sealed proposals on February 1, 2022, at 11:00 AM prevailing time for Providing Services and Programs for the Salem County Senior Residents 60 Years of Age or Older and Limited Disabled Residents; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all proposal results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 5th St, in the County of Salem, Salem, New Jersey, as required by law; and

WHEREAS, it was determined that **Puerto Rican Action Committee of Southern NJ** had substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

WHEREAS, requests for Proposal and Vendor Bid documents have become a part of the contract; and

WHEREAS, the Salem County Board of County Commissioners awarded a contract on February 1, 2022 by Resolution 2022-092 to Puerto Rican Action Committee of Southern NJ in the amount not to exceed \$7,718.00 (Seven Thousand Seven Hundred Eighteen Dollars and Zero Cents) in Federal Funds; and a required Provider match of \$1930.00 (One Thousand Nine Hundred Thirty Dollars and Zero Cents); and

WHEREAS, the contract provided for additional renewal periods which both the County and vendor have consented to exercise; and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract shall be encumbered in account G-02-41-700-23B-303 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the county's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Board of County Commissioners of the County of Salem hereby awards a renewal contract for providing Assisted Transportation for the Salem County Office on Aging and Disabilities subject to the approval of the County Solicitor, to Puerto Rican Action Committee of Southern NJ, 390 N. Broadway, Suite 600/700, Pennsville, NJ 08070 in the amount not to exceed \$8,390.00 (Eight Thousand Three Hundred Ninety Dollars and Zero Cents); and a required Provider match of \$2,097.00 (Two Thousand Ninety-


seven Dollars and Zero Cents) at a cost per unit of \$65.13 (Sixty-five Dollars and Thirteen Cents) during 2023.

2. The contract period is January 1, 2023 through December 31, 2023. The contract shall be completed in full accordance with the terms and conditions of the contract.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all the requirements and specifications.
