RESOLUTION AWARDING A PROFESSIONAL SERVICES CONTRACT FOR FY 2022 DESIGN PREPARATION OF A FIELD SURVEY AND BASE MAPPING FOR WELCHVILLE ROAD, COUNTY ROAD #540 RESURFACING PROJECT FOR THE COUNTY OF SALEM FEDERAL PROJECT NO. STBGP-L5K-0540(303) NJDOT JOB #7100327

WHEREAS, the Design needed for the Welchville Road, County Road #540 Resurfacing Project was approved as a project under the New Jersey Department of Transportation, Transportation Trust Fund Grant Program; and

WHEREAS, five (5) qualified Professional Engineering Firms responded to the advertised "REQUEST FOR PROPOSAL AND QUALIFICATIONS" for FY 2022 DESIGN PREPARATION OF A FIELD SURVEY AND BASE MAPPING FOR WELCHVILLE ROAD, COUNTY ROAD #540 RESURFACING PROJECT FOR THE COUNTY OF SALEM, FEDERAL PROJECT NO. STBGP-L5K-0540(303), NJDOT JOB #7100327 on June 1, 2022 at 11:00 AM; and

WHEREAS, the Board of County Commissioners for the County of Salem have determined that a need exists for the aforementioned Professional Services to assist in the Design of the Resurfacing of Welchville Road, County Road #540; and

WHEREAS, an evaluation of the Proposals based on the criteria outlined in the "Request for Proposal and Qualifications", Technical Proposal, and General Qualifications and Experience on Comparable Projects resulted in "**TAYLOR WISEMAN & TAYLOR**" of Mount Laurel, New Jersey receiving the recommendation of Award of Proposal; and

WHEREAS, the "Request for Proposal and Qualifications" was solicited through a "Fair and Open" process in accordance with N.J.S.A. 19:44A-20.4 et seq; and

WHEREAS, the Salem County Treasurer has certified that the funding for this Professional Services Contract in 2023 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this Contract shall be further contingent upon the availability and appropriation of sufficient funds contained in the 2023 Budget of the County of Salem under the Item: FY22 WELCHVILLE RD CR#540 DES.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. A Professional Services Agreement be issued to "**TAYLOR WISEMAN & TAYLOR**" in accordance with their Proposal for the FY 2022 Design Preparation of a Field Survey and Base Mapping for Welchville Road, County Road #540 2 for the County of Salem for their Total Amount of **FORTY-EIGHT THOUSAND, ONE HUNDRED, SIXTY-EIGHT DOLLARS AND ZERO CENTS** (\$48,168.00).
2. The Director and Clerk of this Board of County Commissioners of the County of Salem are hereby authorized to execute the Contract for "Professional Services" subject to the approval of the County Solicitor and the Commissioner of the New Jersey Department of Transportation.

3. A "Notice of Award" of said Professional Services Contract shall be published as required by law.


