RESOLUTION AWARDING A CONTRACT TO PRODUCE AND DELIVER A MOBILE HEALTH CLINIC FOR THE COUNTY OF SALEM

WHEREAS, the Salem County Purchasing Agent, as authorized contracting Agent for the Board of County Commissioners of the County of Salem has requested, received and opened sealed proposals on April 13, 2023 at 11:00 AM prevailing time to furnish labor, material, equipment, and services necessary to produce and deliver a mobile health clinic for the County of Salem. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all bid results and recommendations are on file in the Office of the Purchasing Agent, 110 Fifth Street, Suite 400, Salem, New Jersey, as required by Law; and

WHEREAS, the Purchasing Agent has determined and certified that the value of the contract will exceed \$17,500: and


WHEREAS, it was determined that the company of Magnum Mobile Specialty Vehicles in Phoenix, Arizona substantially met the necessary qualifications for the fulfillment of the contract, and further provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents shall become a part of the contract; and

WHEREAS, Magnum Mobile has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the County of Salem in the previous year, and that the contract will prohibit them from making any reportable contributions through the term of the contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners hereby awards the contract in the amounts of \$222,800.00 (Two Hundred Twenty-Two Thousand Eight Hundred Dollars and Zero Cents) to furnish labor, material, equipment, and services necessary to produce and deliver a mobile health clinic for the County of Salem, subject to the review of the County Solicitor, to Magnum Mobile Specialty Vehicles, 23225 N. 19th Ave., Phoenix, AZ 85027.
2. The contract shall commence on April 19, 2023 and production of the vehicle will be produced and delivered within 120 days. This shall be completed in full accordance with the terms and conditions of the contract.

3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


