RESOLUTION AMENDING 2023 CONTRACTS FOR PROVIDING DRUG AND ALCOHOL TREATMENT SERVICES (SHORT-TERM RESIDENTIAL) FOR THE SALEM COUNTY DIVISION OF MENTAL HEALTH & ADDICTION SERVICES

WHEREAS, the Board of Chosen Commissioners of the County of Salem through the Division of Mental Health & Addiction Services has awarded contracts for Drug and Alcohol Treatment Services commencing on January 1, 2023, and terminating on December 31, 2023, by Resolution #2023-071; and

WHEREAS, there was a decrease in Maryville’s need for funding for 2023 and Salem County Division of Mental Health & Addiction Services wishes to amend the Short-Term Residential Services contract by decreasing the originally allocated amount of \$6,000.00 (Six Thousand Dollars and Zero Cents) by \$3,000.00 (Three Thousand Dollars and Zero Cents) for a balance of \$3,000.00 (Three Thousand Dollars and Zero Cents); and

WHEREAS, there was an increase in need for New Hope’s Short-Term Residential Services and Salem County Division of Mental Health & Addiction Services wishes to amend the Short-Term Residential Services contract by increasing the originally allocated amount of \$8,000.00 (Eight Thousand Dollars and Zero Cents) by \$3,000.00 (Three Thousand Dollars and Zero Cents) for a balance of \$11,000.00 (Eleven Thousand Dollars and Zero Cents); and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2023 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the county’s temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Commissioners of the County of Salem approves the contract amendment authorizing Maryville to decrease funds allocated by the County of Salem in the amount of \$3,000.00 (Three Thousand Dollars and Zero Cents) and approves the contract amendment authorizing New Hope to increase funds allocated by the County of Salem in the amount of \$3,000.00 (Three Thousand Dollars and Zero Cents).
