**RESOLUTION AWARDING A CONTRACT FOR PROVIDING TWO HANDICAPPED ACCESSIBLE VANS FOR THE OFFICE OF AGING IN THE COUNTY OF SALEM**

**WHEREAS**, the Salem County Purchasing Agent, as authorized contracting Agent for the Board of County Commissioners of the County of Salem requested, received, and opened sealed proposals on September 14, 2023, at 11:00 AM prevailing time for Providing Two Handicapped Accessible Vans for the Office of Aging in the County of Salem. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

**WHEREAS**, all bid results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400, in the County of Salem New Jersey as required by law; and

**WHEREAS**, the Purchasing Agent has determined and certified the value of the contract will exceed \$17,500; and

**WHEREAS**, it was determined that the company of Emergency Equipment Sales & Service, LLC substantially met the necessary qualifications for the fulfillment of the contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents shall become a part of the contract; and

**WHEREAS**, the contract will commence on September 20, 2023, with the production of the vehicles to be produced and delivered no later than November 30, 2023.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners hereby awards a contract for the provision of two handicapped accessible vans, subject to the review of the County Solicitor, to Emergency Equipment Sales & Service LLC , 119 Winterwood Avenue, Ewing, NJ 08638 the cost of which will not exceed \$124,114.00 (One Hundred Twenty-Four Thousand One Hundred Fourteen Dollars and Zero Cents) \$62,057.00 for each of the 2023 Chrysler Voyagers.
2. The contract shall commence on September 20, 2023, and production of the vehicles will be produced and delivered within 60 days. This shall be completed in full accordance with the terms and conditions of the contract.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


