RESOLUTION AMENDING 2023 CONTRACTS FOR PROVIDING DRUG AND ALCOHOL TREATMENT SERVICES (SOBER LIVING FUNDING) FOR THE SALEM COUNTY DIVISION OF MENTAL HEALTH & ADDICTION SERVICES

WHEREAS, the Board of Chosen Commissioners of the County of Salem through the Division of Mental Health & Addiction Services has awarded contracts for Drug and Alcohol Treatment Services commencing on January 1, 2023, and terminating on December 31, 2023, by Resolution #2023-071; and

WHEREAS, there was a decrease in Hendrick House Group's need for funding for 2023 and Salem County Division of Mental Health & Addiction Services wishes to amend the Halfway House Services contract by decreasing the originally allocated amount of \$10,000.00 (Ten Thousand Dollars and Zero Cents) by \$6,000.00 (Six Thousand Dollars and Zero Cents) for a balance of \$4,000.00 (Four Thousand Dollars and Zero Cents); and

WHEREAS, there was an increase in need for Maryville, Inc.'s Sober Living Funding and Salem County Division of Mental Health & Addiction Services wishes to amend the Sober Living Funding Services contract by increasing the previously amended amount of \$40,000.00 (Forty Thousand Dollars and Zero Cents) by \$6,000.00 (Six Thousand Dollars and Zero Cents) for a balance of \$46,000.00 (Forty Six Thousand Dollars and Zero Cents);

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2023 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the county's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Commissioners of the County of Salem approves the contract amendment authorizing Hendricks House Group to decrease funds allocated by the County of Salem in the amount of \$6,000.00 (Six Thousand Dollars and Zero Cents) and approves the contract amendment authorizing Maryville, Inc. to increase funds allocated by the County of Salem in the amount of \$6,000.00 (Six Thousand Dollars and Zero Cents).
