RESOLUTION APPROVING THE EXECUTION OF CHANGE ORDER #1 HOT MIX ASPHALT AND CONCRETE TESTING AND INSPECTION SERVICES FOR THE COUNTY OF SALEM

WHEREAS, the County of Salem issued a Contract in the amount of \$65,180.00 to "COLLIERS ENGINEERING & DESIGN, INC." of Mays Landing, New Jersey for HOT MIX ASPHALT AND CONCRETE TESTING AND INSPECTION SERVICES FOR THE COUNTY OF SALEM on April 5, 2023 per Resolution #2023-178; and

WHEREAS, N.J.A.C. 5:34-4.4(a)3 requires that all change orders for services be approved by the Governing Body; and

WHEREAS, it has been deemed necessary by the Public Works Committee to proceed to Amend the existing Contract for "HOT MIX ASPHALT AND CONCRETE TESTING AND INSPECTION SERVICES FOR THE COUNTY OF SALEM"; and

WHEREAS, all other Terms and Conditions of the original Contract will remain in force; and

WHEREAS, the County Engineer and the Administrator recommend approval of CHANGE ORDER NO. 1, as described on the attached Salem County Change Order Form. The proposed Change will insert two (2) Supplemental Items needed for design of the 2022 Local Freight Impact Fund – Acton Station Road, County Road #653 project that were not previously listed under the existing contract. The insertion of these new items will not increase the overall encumbrance of the contract; and

WHEREAS, the purpose of this Change Order #1 is to approve the Supplemental Items as more particularly described on the attached Salem County Change Order #1 Form.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that CHANGE ORDER NO. 1 be and is hereby approved for execution for the HOT MIX ASPHALT AND CONCRETE TESTING AND INSPECTION SERVICES FOR THE COUNTY OF SALEM; and

BE IT FURTHER RESOLVED that the Director and the Clerk of the Board are hereby authorized to execute said CHANGE ORDER NO. 1.
