RESOLUTION AUTHORIZING AN AGREEMENT WITH CAMDEN COALITION OF HEALTHCARE PROVIDERS FOR INFORMATION EXCHANGE PARTICIPATION

WHEREAS, the Board of County Commissioners of the County of Salem wishes to enter into an agreement with Camden Coalition of Healthcare providers to allow the Salem County Department of Health and Human Services to review patient medical records for the purposes of treatment and care coordination; and

WHEREAS, Salem County will receive funds that were allocated and approved from the state through the Public Health Infrastructure Grant; and

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

- 1. The Director of the Board of County Commissioners of the County of Salem and the Clerk of the Board are hereby authorized to execute an agreement with the said Camden Coalition of Healthcare Providers, in an amount of \$5,000.00.
a. Camden Coalition will underwrite the HIE participation fee for the initial 6 month trial period.
b. Service Period 5/1/24-12/31/24- Invoice amount of \$2,000.00.
c. Service Period 1/1/2025-12/31/25- Annual fee of \$3,000.00 which includes the development of one custom report.
d. Additional custom reports upon request at a fee of \$1,000.00 each which is not included in the annual fee.


