RESOLUTION TO ACCEPT AND EXECUTE THE 2023 RURAL 5311/NONURBANIZED TRANSPORTATION GRANT FUNDING THROUGH NEW JERSEY TRANSIT CORPORATION

WHEREAS, the Salem County Board of County Commissioners authorized the Salem County Office on Aging and Disabilities to submit an application to New Jersey Transit Corporation for the 2023 Rural 5311/Non-Urbanized transportation grant; and

WHEREAS, the grant has imposed financial assistance obligations upon the County of Salem including the provision of the local share of the project costs in the program, in the amount of \$109,942.00 which funds include \$31,227.53 of 2023 carryover funds, \$45,000 from Salem Health and Wellness Foundation, and \$33,714.47 from the County of Salem; and

WHEREAS, the County of Salem was approved by New Jersey Transit Corporation for funding in the amount of \$363,578.00 plus the local share in the amount of \$109,942.00 for a total of \$473,520.00 for the Rural 5311/Non-Urbanized transportation grant for the period covering January 1, 2024 through December 31, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

- 1. The Salem County Board of County Commissioners accepts the grant.
2. The Salem County Office on Aging and Disabilities is hereby authorized to accept the grant on behalf of the County of Salem.


