RESOLUTION AWARDING A PROFESSIONAL SERVICES CONTRACT FOR PORCHTOWN ROAD, COUNTY ROAD #613 DESIGN AND PERMITTING OF STORMWATER MANAGEMENT IMPROVEMENTS AND ROADWAY RESURFACING FOR THE COUNTY OF SALEM

WHEREAS, the County of Salem seeks to secure the services of a Firm to perform DESIGN AND PERMITTING STORMWATER MANAGEMENT IMPROVEMENTS AND ROADWAY RESURFACING FOR THE COUNTY OF SALEM; and

WHEREAS, three (3) qualified Firms responded to the "REQUEST FOR PROPOSAL AND QUALIFICATIONS" on January 24, 2024 at 11:00 AM; and

WHEREAS, the Salem County Board of County Commissioners have determined that a need exists for the aforementioned Professional Services; and

WHEREAS, an evaluation of the Proposals based on the criteria outlined in the "Request for Proposals" resulted in "TAYLOR WISEMAN & TAYLOR" of MOUNT LAUREL, NEW JERSEY receiving the recommendation of Award of Proposal from the "Review Committee"; and

WHEREAS, the "Request for Proposal and Qualifications" was solicited through a "Fair and Open" process in accordance with N.J.S.A. 19:44A-20.4 et seq; and

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

- 1. A Professional Services Contract be issued to "TAYLOR WISEMAN & TAYLOR" in accordance with their Proposal for "Porchtown Road, County Road #613 Design and Permitting of Stormwater Management Improvements and Roadway Resurfacing for the County of Salem" for their Total Amount of THREE HUNDRED, TWENTY-EIGHT THOUSAND, THREE HUNDRED, SEVENTY-ONE DOLLARS and NINETY-TWO CENTS (\$328,371.92).
2. The Director and Clerk of the Salem County Board of County Commissioners are hereby authorized to execute the Contract for "Professional Services" subject to the approval of the County Solicitor.
3. A "Notice of Award" of said Professional Services Contract shall be published as required by law.
