RESOLUTION AUTHORIZING THE USE OF COMPETITIVE CONTRACTING FOR PROVIDING ONE STOP CAREER SERVICES – WIOA TITLE 1-B ADULT, DISLOCATED WORKER AND YOUTH PROGRAMMING SERVICES FOR CUMBERLAND, SALEM, AND CAPE MAY COUNTY BY MEANS OF THE CUMBERLAND, SALEM, CAPE MAY COUNTY WORKFORCE DEVELOPMENT BOARD

WHEREAS, the County of Salem desires to solicit proposals for Providing One Stop Career Services – WIOA Title 1-B Adult, Dislocated Worker and Youth Programming Services by Means of the Cumberland, Salem, Cape May County Workforce Development Board; and

WHEREAS, pursuant to N.J.S.A. 40A:11-4.1k (section 1 of P.L.1999m c440), the County of Salem may use competitive contracting in lieu of public bidding for the operation, management or administration of other services with the approval from the Director of the Division of Local Government Services; and

WHEREAS, under the competitive contract process, the contract Providing One Stop Career Services – WIOA Title 1-B Adult, Dislocated Worker and Youth Programming Services will be awarded to the proposal that, when evaluated, most successfully meets the stated criteria and, therefore, achieves the highest ranking, rather than based solely on the lowest price; and

WHEREAS, the County of Salem desires to conduct the bidding process for the aforesaid services pursuant to the competitive contracting provisions as set forth by the Local Public Contracts Law N.J.S.A. 40A:11-4.1 et seq.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

- 1. The Board of County Commissioners of the County of Salem hereby authorizes the use of the competitive contracting process to solicit and consider proposals for Providing One Stop Career Services – WIOA Title 1-B Adult, Dislocated Worker and Youth Programming Services in Cumberland Salem and Cape May County New Jersey consistent with the requirements of N.J.S.A. 40A:11-4.1 et seq.
