RESOLUTION CONSENTING TO AN AWARD OF A CONTRACT FOR MIDDLE MILE (BROADBAND) GRANT PROGRAM ENGINEERING SERVICES FOR THE COUNTIES OF CUMBERLAND AND SALEM TO EN ENGINEERING, LLC

WHEREAS, on or about April 20, 2022, the Salem County Board of County Commissioners passed Resolution 2022-173 authorizing a Shared Services Agreement between the County of Salem and the County of Cumberland for the Cumberland County/Salem County Broadband Connectivity Project; and

WHEREAS, pursuant to the terms of said Agreement, the County of Cumberland is to serve as the lead agency in the implementation of the goals as aforesaid; and

WHEREAS, in furtherance of the Project, a need exists for Middle Mile (Broadband) Grant Program Engineering Services; and

WHEREAS, the County of Cumberland duly passed a resolution authorizing the use of competitive contracting for the provision of said services, RFP #23-45 pursuant to N.J.S.A. 40A:11-4.3(a); and

WHEREAS, the Cumberland County Purchasing Director recommends the award of a competitive contract to EN Engineering LLC, 28100 Torch Parkway, Suite 400, Warrenville, NJ 60555; and

WHEREAS, the County of Cumberland authorized the award of said contract on February 27, 2024 via Resolution #2024-168; and

WHEREAS, the County of Salem now wishes to consent to and authorize the award of said contract in accordance with the parties Shared Services Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem that the County hereby wishes to join in the award of a contract for Middle Mile (Broadband) Grant Program Engineering Services to EN Engineering, LLC, 28100 Torch Parkway, Suite 400, Warrenville, New Jersey 60555 commencing retroactively from March 1, 2024 and continuing until June 30, 2025 with the option to extend or renew the contract for two (2) additional one (1) year periods, subject to the availability of grant funds as may similarly be extended.

The County of Salem's share of award shall not exceed \$476,610.00.

The Director and Clerk of the Board shall be authorized and directed to execute the contract hereby awarded.
