RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BETWEEN THE COUNTY OF CUMBERLAND, THE COUNTY OF SALEM, THE COUNTY OF GLOUCESTER AND THE CUMBERLAND COUNTY IMPROVEMENT AUTHORITY FOR ENGAGING PROFESSIONAL SERVICES FOR WORK RELATED TO WETLANDS DELINEATION IN FACILITATION OF A REGIONAL JAIL

WHEREAS, the Salem County Board of County Commissioners passed Resolution 2023-522 on December 6, 2023 wherein the County of Salem entered into a Memorandum of Understanding with the County of Cumberland and County of Gloucester dated January 29, 2024 for the development of joint services for inmate transportation, jail operations, rehabilitation and any and all other services related to County obligations on behalf of inmates under local, state and federal law; and

WHEREAS, the proposed site of the jail facility is located on property owned by the County of Salem; and

WHEREAS, the parties wish to enter into a Shared Services Agreement to outline the terms and conditions for engaging professional services for work related to wetlands delineation and application to the NJDEP for a Letter of Interpretation, building design, related grant applications and other necessary expenses related to pending plan approval; and

WHEREAS, the parties recognize that consolidating these services will create long-term cost savings for all parties, will not reduce any prior capabilities, and will improve the interoperability among the Parties; and

WHEREAS, the parties are authorized pursuant to the Uniform Shared Services and Consolidation Act (NJSA 40A:65-1, et seq), to enter into a shared services agreement with any other local unity to provide or receive any service that each local unit could perform on its own;

NOW THEREFORE, BE IT RESOLVED by the Salem County Board of Commissioners hereby authorizes execution of the attached Shared Services Agreement among the County of Cumberland, the County of Salem, The County of Gloucester and the Cumberland County Improvement Authority to outline the terms and conditions for engaging professional services for work related to wetlands delineation and application to the NJDEP for a Letter of Interpretation, related building design and grant applications and other necessary expenses related to pending plan approval and that the Director and Clerk of the Board shall be authorized and directed to execute the Agreement thereto.
