WHEREAS, there exists a need by the County to contract with the Hendricks House Group for providing Halfway House Services; and

WHEREAS, Hendricks House Group represents that it is qualified to perform the said required services, and desires to so perform pursuant to the terms and provisions of this Contact; and

WHEREAS, this Contract is awarded pursuant to, and consistent with, the County's Fair and Open Procurement Process and the terms and provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Salem County Treasurer has certified the funding for this contract shall be encumbered in accordance with N.J.A.C, 50:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's 2024 Budget of the County of Salem under the item Alcohol Comprehensive Grant.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that The Board of County Commissioners of the County of Salem hereby awards the following contract retroactively commencing on January 1, 2024, and terminating December 31, 2024, with Three (3) additional renewal options available pursuant to N.J.S.A. 40A:11-4.2 as follows:

- 1) Halfway House Services Hendricks House Group \$10,000.00


