**RESOLUTION ACCEPTING A GRANT FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE LOCAL AID INFRASTRUCTURE FUND PROGRAM FOR FISCAL YEAR 2023**

**WHEREAS**, the Salem County Engineer’s Office made application to the New Jersey Department of Transportation for funds from the NEW JERSEY DEPARTMENT OF TRANSPORTATION LOCAL AID INFRASTRUCTURE FUND for FISCAL YEAR 2023; and

**WHEREAS**, the Board previously granted approval of the aforesaid application by Resolution No. 2022-498, dated December 28, 2022, and, therefore, approved formal acceptance of this Grant; and

**WHEREAS**, the New Jersey Department of Transportation has obligated fund for the FY 2023 Local Aid Infrastructure Fund Program in the amount of \$480,000.00 for the MILLING AND RECONSTRUCTION OF A 1,125 FOOT LONG SECTION OF NORTH HOOK ROAD, COUNTY ROAD #551 beginning at Station 143+75 extending to Station 155+00 in Pennsville Township for the County of Salem; and


**WHEREAS**, no funding match is required for this Grant; and

**WHEREAS**, this Grant and Project are to be referenced as the 2023 LOCAL AID INFRASTRUCTURE FUND PROGRAM.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that:

1. The GRANT AGREEMENT, as received through the New Jersey Department of Transportation “PMRS” System, be Accepted.
2. The Chief Finance Officer and the contact person from the Salem County Engineer’s Office, as well as other necessary parties, are hereby authorized and directed to execute all Grant requirements and documentation filings as directed by the New Jersey Department of Transportation.
3. Two (2) fully executed copies of this resolution shall be provided to the Salem County Engineer’s Office forthwith.
