**RESOLUTION APPROVING THE EXECUTION OF  
CHANGE ORDER #4  
RESURFACING AND SAFETY IMPROVEMENTS  
SOUTH GREENWICH STREET/TELEGRAPH ROAD,  
COUNTY ROAD #540, PHASE 1  
FOR THE COUNTY OF SALEM  
FEDERAL PROJECT NO. STBGP-L5K-0540(304)  
NJDOT JOB NO. 7101317**

**WHEREAS**, the County of Salem issued a Contract in the amount of \$842,824.65 to "South State, Inc." of Bridgeton, New Jersey for the "RESURFACING AND SAFETY IMPROVEMENTS SOUTH GREENWICH STREET/TELEGRAPH ROAD, COUNTY ROAD #540, PHASE 1 FOR THE COUNTY OF SALEM, FEDERAL PROJECT NO. STBGP-L5K-0540(304), NJDOT JOB NO. 7101317" on June 21, 2023 per Resolution #2023-268; and

**WHEREAS**, N.J.A.C. 5:34-4.4(A) 3 requires that all Change Orders for Capital Projects be approved by the Board of County Commissioners; and

**WHEREAS**, the County Engineer and Administrator recommend the approval of CHANGE ORDER #4 as described on the attached New Jersey Department of Transportation Federal Aid Change Order #4 Form and the County of Salem Change Order #4 Form which represents a THIRTY (30) day time extension, only, which in addition to Change Order No's 1, 2 and 3 represents a 1.7% INCREASE in the Total Contract Cost resulting in a Total Contract Cost of \$857,564.65; and

**WHEREAS**, this Project is Funded through the NEW JERSEY DEPARTMENT OF TRANSPORTATION, FEDERAL AID PROGRAM; and

**WHEREAS**, the purpose of this Change Order #4 is to approve an additional 30-day time extension only, as more particularly described on the attached New Jersey Department of Transportation Federal Aid Change Order #4 Form; and

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that this CHANGE ORDER #4 be and is hereby approved for execution for the "RESURFACING AND SAFETY IMPROVEMENTS SOUTH GREENWICH STREET/TELEGRAPH ROAD, COUNTY ROAD #540, PHASE 1 FOR THE COUNTY OF SALEM, FEDERAL PROJECT NO. STBGP-L5K-0540(304) NJDOT JOB NO. 7101317; and

**BE IT FURTHER RESOLVED** that the Commissioner Director and the Clerk of this Salem County Board of County Commissioners be authorized to execute said NJDOT FEDERAL AID PROJECT CHANGE ORDER #4 FORM and the SALEM COUNTY CHANGE ORDER #4 FORM.
