RESOLUTION AMENDING RESOLUTION 2023-354 THE NEW JERSEY DEPARTMENT OF HEALTH (NJDOH)- OFFICE OF LOCAL PUBLIC HEALTH'S (OLPH) COUNTY HEALTH INFRASTRUCTURE PROGRAM 2024

WHEREAS, the Salem County Board of County Commissioners adopted Resolution 2023-354 on September 6, 2023 which Authorized the Acceptance and Execution of a Grant from The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024 for the period of July 1, 2023, through June 30, 2026 in the total amount of \$287,782.00 (Two Hundred Eighty Seven Thousand Seven Hundred Eighty Two Dollars and Zero Cents).

WHEREAS, NJDOH made funding available for the period of July 1, 2023 through, June 30, 2024 (Year 1) in the amount of \$143,891.00 (One Hundred Forty Three Thousand Eight Hundred Ninety One Dollars and Zero Cents); and

WHEREAS, the Salem County Department of Health and Human Services has received notice from the New Jersey Department of Health that funding for Years two (2) and three (3) will be awarded in Year two (2) in the amount of \$143,891.00 (One Hundred Forty-Three Thousand Eight Hundred Ninety-One Dollars and Zero Cents) and extending the budget period; and

WHEREAS, the total grant funds awarded for The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024 for Years one (1), two (2), and three (3) is \$287,782.00 (Two Hundred Eighty Seven Thousand Seven Hundred Eighty Two Dollars and Zero Cents) for the budget period of July 1, 2023 through December 31, 2024. The project period for this funding will remain July 1, 2023 through June 30, 2026.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that they authorize the acceptance of the additional funding for Years two (2) and three (3) in the amount of \$143,891.00 (One Hundred Forty Three Thousand Eight Hundred Ninety One Dollars and Zero Cents) and the extension of the budget period to December 31, 2024 for The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024.
