RESOLUTION AMENDING RESOLUTION 2024-155 TO ADD ADDITIONAL FUNDING TO THE NEW JERSEY DEPARTMENT OF HEALTH (NJDOH)- OFFICE OF LOCAL PUBLIC HEALTH'S (OLPH) COUNTY HEALTH INFRASTRUCTURE PROGRAM 2024

WHEREAS, the Salem County Board of County Commissioners adopted Resolution 2023-354 on September 6, 2023 which Authorized the Acceptance and Execution of a Grant from The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024 for the period of July 1, 2023, through June 30, 2026 in the total amount of \$287,782.00 (Two Hundred Eighty Seven Thousand Seven Hundred Eighty Two Dollars and Zero Cents); and

WHEREAS, NJDOH made funding available for the period of July 1, 2023 through, June 30, 2024 (Year 1) in the amount of \$143,891.00 (One Hundred Forty Three Thousand Eight Hundred Ninety One Dollars and Zero Cents); and

WHEREAS, the Salem County Board of County Commissioners adopted Resolution 2024-155 on April 3rd, 2024 which Authorized the Acceptance of additional funding for Years 2 and 3 in the amount of \$143,891.00 (One Hundred Forty Three Thousand Eight Hundred Ninety One Dollars and Zero Cents) and the extension of the budget period to December 31, 2024 for The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024; and

WHEREAS, the total grant funds awarded for The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024 for Years 1, 2, and 3 was \$287,782.00 (Two Hundred Eighty Seven Thousand Seven Hundred Eighty Two Dollars and Zero Cents); and


WHEREAS, the Salem County Department of Health and Human Services has received notice from the New Jersey Department of Health that additional funding in the amount of \$7,255.00 (Seven Thousand Two Hundred and Fifty-Five Dollars and Zero Cents) has been made available to the Salem County Department of Health and Human Services; and

WHEREAS, the total grant funds awarded for The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024 for Years 1, 2, and 3 is now \$295,037.00 (Two Hundred Ninety-Five Thousand Thirty-Five Dollars and Zero Cents); and

WHEREAS, the project and budget periods have not changed.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that they authorize the acceptance of the additional funding in the amount of \$7,255.00 (Seven Thousand Two Hundred and Fifty-Five Dollars and Zero Cents) for The New Jersey Department of Health (NJDOH)- Office of Local Public Health's (OLPH) County Health Infrastructure Program 2024.
