**RESOLUTION APPROVING THE EXECUTION OF CHANGE ORDER #1 TO THE  
2019 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM**

**WHEREAS**, the County of Salem issued a Contract in the amount of \$5,967,515.89 (Five Million Nine Hundred Sixty-Seven Thousand, Five Hundred Fifteen Dollars and Eighty Nine Cents) to "South State, Inc." of Bridgeton, New Jersey for the "2019 County Aid Road Program for the County of Salem" on July 19, 2023 per Resolution #2023-299; and

**WHEREAS**, N.J.A.C. 5:30-11.1 requires that all Change Orders for Capital Projects be approved by the Board of County Commissioners; and

**WHEREAS**, the County Engineer and Administrator recommend the approval of Change Order #1 as described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #1 Form and the County of Salem Change Order #1 Form which represents a One Hundred and Twenty (120) day time extension, as well as a Project Increase of \$214,838.30 (Two Hundred Fourteen Thousand, Eight Hundred Thirty-Eight Dollars and Thirty Cents), which represents a 2.08% Increase in the Total Contract Cost, resulting in a Total Contract Cost of \$6,182,354.19 (Six Million, One Hundred Eighty-Two Thousand, Three Hundred Fifty-Four Dollars and Nineteen Cents); and

**WHEREAS**, this Project is funded through the New Jersey Department of Transportation, County Aid Improvement Program; and


**WHEREAS**, the purpose of this Change Order #1 is to approve Overage Items, Supplemental Items, and a Time Extension, as described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #1 Form; and

**WHEREAS**, the Salem County Treasurer has certified that funding for this contract change order shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this Change Order shall further be contingent upon the availability and appropriation of sufficient funds contained in the 2024 Budget of the County of Salem under the item: 2016 County Aid Improvement Program, NJDOT; Account #G-02-41-764-16A-303; \$214,838.30 (Two Hundred Fourteen Thousand, Eight Hundred Thirty-Eight Dollars and Thirty Cents).

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that this Change Order #1 is hereby approved for execution for the "2019 County Aid Road Program for the County of Salem"; and

**BE IT FURTHER RESOLVED** that the Commissioner Director and the Clerk of the Board of Salem County Board of County Commissioners be authorized to execute the said NJDOT, Local Aid Projects Change Order #1 Form and Salem County Change Order #1 Form.


