RESOLUTION AMENDING 2024 CONTRACT FOR PROVIDING DRUG AND ALCOHOL TREATMENT SERVICES (RECOVERY TRANSPORTATION) FOR THE SALEM COUNTY DIVISION OF MENTAL HEALTH & ADDICTION SERVICES

WHEREAS, the Board of County Commissioners of the County of Salem through the Division of Mental Health & Addiction Services has awarded contracts for Drug and Alcohol Treatment Services commencing on January 1, 2024, and terminating on December 31, 2024, by Resolution #2024-068; and

WHEREAS, there was an increase in need for B.R. William’s Recovery Transportation Services and Salem County Division of Mental Health & Addiction Services wishes to amend the Recovery Transportation Services contract by increasing the original contract amount of \$11,000.00 (Eleven Thousand Dollars and Zero Cents) by \$15,000.00 (Fifteen Thousand Dollars and Zero Cents) for a balance of \$26,000.00 (Twenty-Six Thousand Dollars and Zero Cents);

WHEREAS, the additional funds of \$15,000.00 (Fifteen Thousand Dollars and Zero Cents) will come from the following sources: \$6,000.00 (Six Thousand Dollars and Zero Cents) of funding is from an unawarded Outpatient Services contract and \$9,000.00 (Nine Thousand Dollars and Zero Cents) is from funding set aside for Narcan kit supplies;

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2024 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the county’s temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners approves the contract amendment authorizing B.R. William’s to increase funds allocated by the County of Salem in the amount of \$15,000.00 (Fifteen Thousand Dollars and Zero Cents) for a balance of \$26,000.00 (Twenty-Six Thousand Dollars and Zero Cents).
