RESOLUTION APPROVING THE EXECUTION OF CHANGE ORDER #2 FOR THE 2019 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM

WHEREAS, the County of Salem issued a Contract in the amount of \$5,967,515.89 (Five Million, Nine Hundred Sixty-Seven Thousand, Five Hundred Fifteen Dollars and Eight-Nine Cents) to "South State, Inc." of Bridgeton, New Jersey for the "2019 County Aid Road Program for The County of Salem" on July 19, 2023 per Resolution #2023-299; and

WHEREAS, the Salem County Board of County Commissioners adopted Resolution #2024-200 on May 1, 2024 authorizing Change Order #1 to said contract for an additional cost of \$214,838.30 (Two Hundred Fourteen Thousand, Eight Hundred Thirty-Eight Dollars and Thirty Cents); and

WHEREAS, N.J.A.C. 5:30-11.1 requires that all Change Orders for Capital Projects be approved by the Board of County Commissioners; and

WHEREAS, the County Engineer and Administrator recommend the approval of Change Order #2 as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2 Form and the County of Salem Change Order #2 Form which represents a One Hundred and Forty-Five (145) day time extension, as well as a Project Increase of \$110,324.51 (One Hundred, Ten Thousand, Three Hundred, Twenty-Four Dollars and Fifty-One Cents), which in addition to Change Order #1 represents a 5.05% INCREASE in the Total Contract Cost, resulting in a Total Contract Cost of \$6,292,678.70 (Six Million, Two Hundred Ninety-Two Thousand, Six Hundred Seventy-Eight Dollars and Seventy Cents); and

WHEREAS, this Project is funded through the New Jersey Department of Transportation, County Aid Improvement Program; and

WHEREAS, the purpose of this Change Order #2 is to approve a Supplemental Item, and a Time Extension, as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2 Form.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that this Change Order #2 be and is hereby approved for execution for the "2019 County Aid Road Program for The County of Salem"; and


