**RESOLUTION RENEWING A CONTRACT FOR PROVIDING ORIGINAL EQUIPMENT MANUFACTURED NJ TRANSIT BUS PARTS FOR THE COUNTY OF SALEM**

**WHEREAS**, the Salem County Purchasing Department, as authorized contracting Agent for the Board of County Commissioners of the County of Salem requested, received, and opened sealed proposals on July 13, 2023, at 11:00 AM prevailing time for Providing Original Equipment Manufacturer (OEM) Transit Bus Parts for the County of Salem. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

**WHEREAS**, it was determined that the company of New Flyer Industries. Inc. (NFI) substantially met the necessary qualifications for the fulfillment of the contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents shall become a part of the contract; and


**WHEREAS**, the Board of County Commissioners of the County of Salem adopted Resolution 2023-287 awarding a contract to New Flyer Industries, (NFI); and

**WHEREAS**, the original contract provided for an additional one (1) year renewal or extension and NFI and the Salem Couty Board of County Commissioners are interested in exercising the one (1) year renewal of said contract with the same terms and conditions as outlined in the bid specifications and proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners hereby awards a contract for the provision of OEM NJ Transit Bus Parts, subject to the review of the County Solicitor, to New Flyer Industries Inc. the cost of which will not exceed \$60,000.00 (Sixty Thousand Dollars and Zero Cents).
2. The contract shall commence on August 1, 2024, and terminate on July 31, 2025, with no additional renewals or extensions. This shall be completed in full accordance with the terms and conditions of the contract.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
